What does it offer?

You could receive **30 per cent off** your tuition fees for the duration of your course.

What does it offer?

You could receive up to **30 per cent off** your tuition fees for the duration
of your course, depending on your
GPA (or equivalent). You must have
achieved an academic result of **at least 60 per cent GPA** Australian
standard equivalent to be eligible for
this scholarship. Master of Information
Technology (Professional Computing)
students are eligible to receive
A\$2500 off their tuition fees.

What does it offer?

You could receive **A\$2500 to A\$4000 off** your pathway course tuition.

Which courses are included?

To be eligible for this scholarship, you must be applying for one of the following STEM courses:

- Master of Construction and Infrastructure Management
- Master of Data Science
- Master of Information Technology.

Which courses are included?

- Master of Business Administration (MBA)
- Master of Information Technology (Professional Computer).

Which courses are included?

Postgraduate Qualifying Program (PQP) + one of the following courses:

- Master of Business Administration (MBA)
- Master of Data Science
- Master of Information Technology.

Eligibility criteria

To be eligible for an international scholarship, you must:

- be an international student (citizens of Australia or New Zealand and permanent residents of Australia are not eligible)
- not be holding another scholarship or reduced fee arrangement from Swinburne
- satisfy any course or scholarship-specific entry requirements.
